State Finals Summary

Park Tudor Downs South Bend St. Joseph's In Championship Match

Park Tudor captured its fifth IHSAA Boys State Tennis Team Championship on Saturday afternoon, October 19, 2002, with a 4-1 victory over South Bend St. Joseph's in the championship match at North Central High School in Indianapolis.

For the Panthers it was their fourth state title in the last eight years, having also won it all in 1996, 1997, and 1998. Park Tudor, also defeated South Bend St. Joseph's for the 1990 crown, 5-0. Dave Heffern has been the Park Tudor coach for the last four championship teams.

Park Tudor finished the season with a 20-3 dual meet record and was ranked fifth in the final Indiana High School Tennis Coaches Association poll prior to the start of state tournament competition.

In their 4-1 semifinal victory over Homestead, the Panthers won matches at No. 2 and 3 singles with John Schier and Michael Scanlon, respectively, and at No. 1 doubles with Ryan Gershman and John Lee and at No. 2 doubles featuring Robby Goad and Elliot Sosbey. They used the same winning combination to take the championship match as well.

St. Joseph's, ranked 10th in the final poll, finished the season at 20-1 under head coach Eric Mahone defeating Jasper, 4-1 in the other semifinal. Senior Ryan Keckley, the Indians' No. 1 singles player, won both of his matches and continued his unbeaten season at 18-0, defeating Park Tudor's Blake Elder in the championship match 6-2, 6-3.

Homestead edged Jasper, 3-2, for third place in the consolation match.

Andrew Skillman of Jasper High School was named the Mental Attitude Award winner for Boys Tennis by the IHSAA Executive Committee. Farm Bureau Insurance, the IHSAA's corporate partner, presented a \$1,000 scholarship to Jasper High School in the name of Skillman.

Three hundred and twelve teams and 3,042 young men participated in the boys tennis tournament series this season.

St. Joseph's Keckley, North Central's Hollander and Valinetz Capture Tennis Titles

South Bend St. Joseph's Ryan Keckley and the North Central doubles team of Ryan Hollander and Adam Valinetz were crowned state champions after winning their respective tournaments on October 26, 2002 at Five Seasons Sports Country Club in Indianapolis.

Keckley completed a perfect 26-0 season (10-0 in tournament play) with a 6-3, 6-1 victory over Kokomo senior Matt Zollman in the championship match of the IHSAA state tournament for No. 1 singles players. The senior becomes the first St. Joseph's player to win the state singles tournament and the first to play in the title match since Chris Varga finished as the runner-up in 1997. Zollman, who finished 27-2, was the first Kokomo player to make it to the final round. This year's match for all the marbles was a repeat of last year's consolation match which Keckley also won 6-2, 6-3.

Keckley, who received a bye into the semifinals after leading his team to a state runner-up finish one week ago, earned his spot in the championship contest following an impressive 6-0, 6-0 victory over defending state champion and previously unbeaten Tom Murphy of Indianapolis Cathedral. The Keckley-Murphy meeting was a rematch of last year's semifinal in which Murphy won, 6-3, 6-4, and went on to win capture the state title. Zollman was the third piece to last year's semifinal puzzle falling in the semis and settling for fourth place a year ago.

This season, Murphy (25-1) took third place defeating Silver Creek's Brandon Lenfert in the consolation match, 4-6, 6-1, 7-5. Lenfert suffered his only two setbacks of the year on Saturday, falling to Zollman in the other semifinal match, 6-4, 0-6, 6-3, to wind up 27-2.

In doubles, Hollander and Valinetz took a straight set victory from Park Tudor's Ryan Gershman and Jon Lee, 7-5, 6-0, in the championship competition to finish 26-1, including 8-0 in the post-season.

It was the North Central duo's third victory in three meetings this season between the neighboring schools' top doubles teams. Gershman and Lee, who helped lead Park Tudor to the team championship last weekend at No. 1 doubles and earned a bye into the semifinals, concluded a 21-3 campaign.

Hollander and Valinetz also became the fifth North Central team to win the doubles tournament and first in seven years. They won a three-set match over the previously undefeated Delta team of Patrick Bryan and Alan Robinson, 6-2, 4-6, 6-1 for a spot in the final. Gershman and Lee tallied a 6-4, 6-4 triumph over Lowell seniors Justin Bales and Ryan Brown in the other semi.

The Delta team won the match for third place over Lowell, 7-6 (7-4), 7-5.

Friday's quarterfinal matches were forced indoors due to steady rain throughout the day. Saturday's semifinal round matches, though never threatened by rain, were delayed by over an hour due to moisture on the courts.
