

2002-03 IHSAA Volleyball State Tournament Series

State Finals Summary

Muncie-area schools swept the four state championships as Muncie Central in Class 4A, Delta in 3A, Muncie Burriss in 2A and Wapahani in A walked away with the state's top honors in the 31st Annual IHSAA Volleyball State Finals on Saturday, November 9, 2002 in Indianapolis.

Indiana was one of several states across the country that took part in a season-long rally scoring experiment sponsored by the IHSAA's parent organization, the Indianapolis-based National Federation of State High School Associations (NFHS). In rally scoring, points are awarded on each play, regardless of which team serves, as opposed to the traditional sideout system.

A total of 5,386 student-athletes from 383 schools were entered in the state tournament. North Central (4A), Lawrence North (3A) and Ben Davis (2A) high schools, all in Indianapolis, along with Hinkle Fieldhouse (A) served as state semifinal sites in the morning with all four championship matches being played at Hinkle in the afternoon and evening.

Class 4A

Muncie Central Completes The Sweep For Delaware County Schools

Muncie Central used heavy hitting to jump to early leads and cruised to a three-game sweep of Penn, 21-17, 21-10, 21-12, for the Class 4A state title.

The Bearcats, winners of 31 straight matches and top-ranked in their class under coach Dave Shondell, claimed their fourth volleyball championship and first since 1999. The Bearcats were big school champs in 1997, 1998 and 1999.

Penn, meanwhile, finished winners in 20 of its last 22 matches and finished 34-5 under coach Lisa Pawlik.

Interestingly, Muncie Central's victory sealed a complete sweep of all four state titles by Delaware County schools as Wapahani, Muncie Burriss and Delta also claimed their respective class championships earlier in the day. It marks the first time in any IHSAA sport that that has happened.

Senior Joselyn Johnson led Muncie Central with 12 kills for a .556 percentage in 18 attempts, while sophomore Kelli Miller finished with 11 kills. Senior Samantha Bird led with 12 digs and sophomore Kelli Miller and junior Caitlin Stassen each contributed 10. Senior Jessie Fox led Penn with seven kills and senior Kelsey Doll added 12 digs on defense.

Muncie Central also swept past Bloomington North in their opener, 21-16, 21-14, 21-13, while Penn advanced to its first title match by unseating defending state champion Indianapolis Cathedral, 21-18, 9-21, 21-17, 21-14.

Class 3A

Delta Batters Fort Wayne Bishop Luers For Second Year

Both teams found their way back and, again, it was the same result as Delta swept Fort Wayne Bishop Luers, 21-13, 21-13, 21-19, in the Class 3A championship match.

A year ago, Delta won its first state title defeating a surprising Bishop Luers team, 15-5, 15-5, and this year's match played out much the same way as the third-ranked Eagles led most of the way.

After Delta took the first two games, the two teams exchanged the lead five different times in the deciding set before Delta put the match away.

Senior Sarah McGill led the way with 13 kills for Delta and hit for .381 in 21 attempts. Fellow senior Ashley DeNeal added 10 kills of her own and had a team-high eight digs. Senior Andrea Vachon tallied six kills in 10 attempts for a .500 hitting percentage to lead Bishop Luers' cause.

Delta was coached by Robb Painter, who led his team to a 32-7 slate. Luers, under coach Joyce Moss, concluded a 31-9 campaign.

Delta earned its berth into the championship match via a 21-15, 21-15, 21-15 victory over Highland. Bishop Luers prevailed in a five-game test against Providence, 19-21, 21-17, 21-12, 16-21, 15-12, in the second semifinal matchup.

Class 2A

Muncie Burris Rolls To Sixth Straight Championship

Muncie Burris held on in what turned out to be a tight game two and went on to capture its sixth consecutive state championship in Class 2A.

After taking the first game, Burris kept its composure and held off a furious Brownstown Central rally that saw the Braves erase nearly all of an 11-point deficit. Burris led 18-7 before Brownstown pulled to within one point at 19-18, but were unable to tie before the Owls finished it off and went on to a 21-14, 21-19, 21-15 victory.

It was the 14th volleyball state championship in Burris' rich history all under the guidance of coach Steve Shondell, Indiana's all-time coaching leader in terms of victories as well as state championships.

The Owls (34-6) were led by senior Amanda McCormick's 10 kills and seven defensive digs. Classmate Alice Enochs tallied seven kills and sophomore Hana Ros also dug seven on defense. Sophomore Whitney McCory led Brownstown Central with six kills and 10 digs, but the Braves were plagued with a negative .029 hitting percentage on offense for the match much of it due to Burris' 11 total blocks. Senior Rachel VonDielingen collected 12 digs to lead Brownstown Central.

It was the third state runner-up finish in Class 2A (1998, 1999) for 36-3 Brownstown Central all three times coming up short against Burris. The Braves were coached by Jennifer Shade.

Burris had little trouble defeating Union County, 21-14, 21-14, 21-8, in the semifinals, while Brownstown Central bested Triton, 21-16, 21-14, 21-12 in the other match.

Class A

Wapahani Ends Michigan City Marquette's Run With Convincing Win

Second-ranked Wapahani scored an impressive three-game victory over three-time defending state champion and top-ranked Michigan City Marquette for the Class A state championship.

With the 21-18, 21-12, 21-14 victory, the Raiders, first time participants in the volleyball state finals, captured the first IHSAA state title in school history in a team or individual sport.

Wapahani was led in kills by juniors Danielle Hazelbaker and Allison Shaw with 11 each. Hazelbaker finished with a .526 hitting percentage in 19 attempts. Classmate Maren Crabtree assisted on 25 of those kills and led the team with 11 digs. Hazelbaker dug 10 attempts on defense herself.

Marquette, making its fourth consecutive trip to the final match in Class A, suffered its first loss in 22 matches. The Blazers got 11 kills and 11 digs from senior Kelly Cochran, but the team suffered through a .100 hitting percentage.

Coached by Mike Lingenfelter, Wapahani finished 35-6, including victories in 28 of their last 29 matches. Marquette was coached by Jim Dove, Jr. and completed a 35-4 season.

In the morning semifinals, Wapahani advanced with a victory over Oldenburg Academy, 21-11, 21-12, 21-12, while Marquette swept Tecumseh, 21-13, 21-9, 21-9, for its spot in the final.
